EXEMPLARY PRACTICE: RANCHEVIEW SCHOOL STUDIO XP - YEAR THREE UPDATE

Project Description:

StudioXP is a combined Grade 7 and 8 class at RancheView school that started in 2019. The goal of the class is to provide learning that integrates Career and Technology Foundation (CTF) skills and experiences with core curriculum objectives. It is meant to meet the needs of diverse learners while connecting learners to their passions and, at the same time, develop their creative confidence to show they can respond to the needs of their communities and world. Studio XP was designed to align with RVS' Four-Year Plan.

This update will give an inside look at how an "Innovators Mindset" helped students and teachers overcome the challenges presented during the COVID-19 pandemic, and show how the class has implemented the Leverage, Engage, Appreciate, Reflect, Nurture (LEARN) principles to help drive students' ability to connect their learning meaningfully to the world around them. It will also highlight current projects the class is involved in, including Coding Your Own Adventure, Skills Exploration Day and Watershed Development.
