EXEMPLARY PRACTICE: W.G. MURDOCH MUSEUM OF HUMAN RIGHTS PROJECT

Teachers: Molly Maguire

Project Description

As part of social studies, Grade 10 students at W.G. Murdoch recently presented their Museum for Human Rights. Guided by Teacher Molly Maguire, this project-based learning saw students choose a topic in human rights to research and create an exhibit about that topic. The exhibits were displayed on Jan. 17 for the entire school, along with families, to visit.

This project began with a virtual field trip to the Canadian Museum for Human Rights in Winnipeg, to spark the students' interest and show them examples of what their museum would look like. In addition to researching their topic, the class also planned the date and venue of the museum, sent out invites and created promotional materials. In addition to their research, students also had to contemplate a call to action related to their topic, such as a fundraiser or a letter writing campaign. Because the museum was student-centred and student-driven, it increased their motivation and engagement.

This project connects to several outcomes of RVS' Education Plan. In choosing and researching their human rights topic, students were actively engaged in meaningful and relevant learning. Throughout the project, students demonstrated critical thinking, communication, problem solving, collaboration, cultural and global citizenship, creativity and personal growth.
